TRADERS BAY PARTNERS NETWORK (TBPN) PARTNERSHIP TERMS & CONDITIONS

1. Introduction

The Traders Bay Partners Network (TBPN), previously known as the Traders Bay Referral Program, is a structured partnership initiative through which approved individuals (“Partners”) promote Traders Bay services and earn commission based on successful referrals.

TBPN represents the continued development, expansion, and refinement of the existing referral system previously operated under Traders Bay.

All individuals who previously participated in the Traders Bay Referral Program shall, where applicable, fall within the scope of this updated framework.

By participating in TBPN, the Partner confirms that they have read, understood, and agreed to these Terms and Conditions.

2. Nature of Relationship

The Partner acts as an independent promoter and is not an employee, agent, or legal representative of Traders Bay.

Nothing in this Agreement creates:

- employment
- partnership in law
- joint venture
- fiduciary relationship
- authority to bind Traders Bay

3. Eligibility & Approval

Participation is subject to approval by Traders Bay.

- accept or decline any application
- suspend or revoke Partner status at its discretion

4. Partner Role & Scope

The Partner's role is limited to:

- introducing prospective clients
- sharing approved information
- facilitating initial engagement

Partners shall not:

- provide trading advice
- teach Traders Bay methodologies
- guarantee results or outcomes
- act as mentors under Traders Bay

5. Commission Structure and Payment Conditions

Commission is earned only on successfully converted referrals, subject to:

- confirmed receipt of payment
- verification of referral origin
- compliance with this Agreement

For clarity:

- (a) Commission is based on actual funds received, not quoted or expected value;
- (b) Where a client is on an instalment plan, commission is paid proportionally as payments are received;
- (c) No commission is payable on unpaid balances, cancellations, or defaulted instalments;
- (d) Commission may vary based on promotions, deal structures, or special arrangements;
- (e) Partners are responsible for confirming applicable commission structures through official Traders Bay channels;
- (f) Traders Bay retains final authority on all commission determinations.

No commission is payable on:

- refunded transactions
- reversed or disputed payments
- invalid referrals

6. Referral Integrity

A valid referral must:

- be a new client
- result directly from the Partner's effort
- be verifiable

All determinations remain at the discretion of Traders Bay.

7. Brand & Communication Standards

Partners must represent Traders Bay accurately and professionally.

Partners shall not:

- make misleading or exaggerated claims
- guarantee profits or outcomes
- misrepresent services
- create unauthorized marketing material

All communication must align with official messaging.

8. Use of Brand & Resources

All materials and branding remain the property of Traders Bay.

Partners may use them only for approved promotional purposes.

Partners shall not:

- modify branding
- use identity outside scope
- continue use after termination

9. Non-Circumvention & Client Protection

Partners shall not:

- redirect Traders Bay clients
- build competing relationships using Traders Bay connections
- interfere with client relationships

All client relationships remain the business of Traders Bay.

10. Good Faith Conduct

Partners must act in good faith and support the integrity of Traders Bay.

Manipulation, misinformation, disruption, or reputational harm constitutes breach.

11. Limitation of Authority

Partners may not:

- negotiate pricing
- alter terms
- bind Traders Bay

All transactions are handled by Traders Bay.

12. Confidentiality and Non-Disclosure

Partners may access confidential information including:

- internal strategies
- pricing and commission structures
- workshops and training sessions
- calls, voice notes, and discussions
- client and lead information

Partners shall:

- keep all information confidential
- not share or reproduce it
- not use it outside this Agreement

This applies to:

- workshops
- calls
- messaging
- all forms of communication

This obligation survives termination.

13. Commission Disputes

Disputes must be supported by evidence.

Traders Bay may:

- investigate
- withhold payments
- make final determinations

All decisions are final.

14. Rewards & Incentives

Rewards may be offered at Traders Bay's discretion.

These may include:

- bonuses
- devices
- financial incentives
- travel

All rewards are conditional and not guaranteed.

15. Termination

Traders Bay may terminate immediately for:

- breach
- misconduct

Termination may include:

- loss of status
- forfeiture of commissions
- removal of access

16. Post-Termination Obligations

The Partner shall:

- cease representation
- stop using branding
- not imply affiliation

17. Non-Interference

Partners shall not disrupt operations, clients, or other partners.

18. Breach & Remedies

Traders Bay may:

- terminate
- withhold commissions
- recover losses
- pursue legal action

19. Digital Evidence

All communications may be used as evidence, including:

- messages
- voice notes
- screenshots
- activity logs

21. Entire Agreement

This document represents the full agreement.

22. Strategic Partner Development, Resource Investment and Lead Ownership

Traders Bay may provide selected Partners with enhanced support, including:

- financial investment
- devices and tools
- travel and accommodation
- branding and content support
- platform exposure
- lead allocation

The Partner acknowledges: PARTNERS NETWORK

- (a) all support advances Traders Bay's business interests;
- (b) resulting growth is not solely attributable to the Partner;
- (c) all leads generated through Traders Bay's platforms, brand, systems, marketing efforts, or strategic support remain the sole business interest of Traders Bay;
- (d) the Partner engages such leads on behalf of Traders Bay and does not own such relationships;
- (e) commission structures may be adjusted to reflect Traders Bay's contribution;
- (f) special arrangements may be formalized separately;
- (g) no advantage gained through Traders Bay may be used to compete or undermine it;
- (h) leads or opportunities derived from Traders Bay may not be independently commercialized;
- (i) independently generated leads, not derived from Traders Bay's ecosystem, remain outside this ownership, provided they are not influenced by Traders Bay resources or positioning.

Misuse constitutes a material breach.

- misrepresent services

Partners are responsible for all communication made through their channels.

24. Payment Handling Restrictions

Partners shall not:

- collect or receive funds from clients
- provide alternative payment methods
- enter private payment arrangements

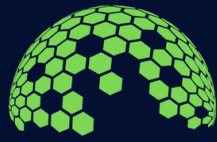
All payments must go directly to Traders Bay.

Traders Bay is not liable for:

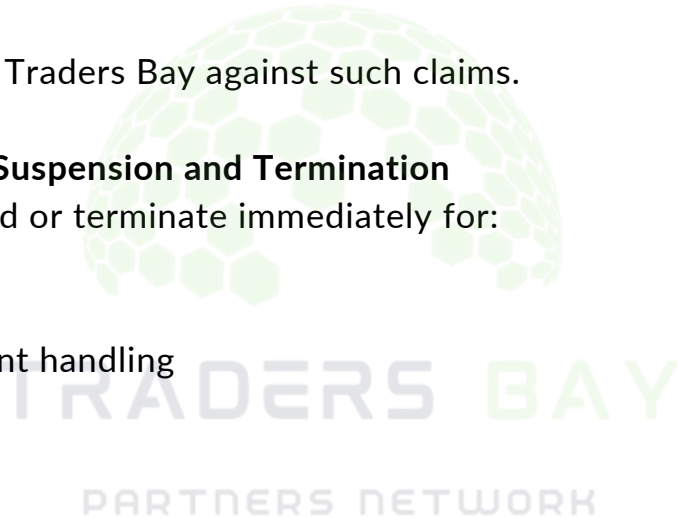
- partner misrepresentation
